Subject: Transport Management – Regulation of Vehicle Entry in School Premises

Jai Hind Dear Parents !

As per the directions received, certain changes have been made in the transport and parking arrangements to ensure safety and smooth movement of school students within the Air Force Station and school area, as the school has been declared as “NO DRIVE ZONE”. Kindly note the following guidelines to be followed with effect from 01 Nov 2025:

1. No Vehicle Entry Inside the School

1.1. No vehicles (cars, two-wheelers, autos, or vans) will be allowed to enter the school premises.

1.2. This step has been taken in compliance with Air HQ instructions and for the safety and discipline of all students.

1.3. Students commuting by bicycle will be allowed entry from the **Main Gate (Gate No. 2)** and may park their bicycles in the designated cycle stand.

2. Drop-Off and Pick-Up by Parents

2.1. For Parents residing within the AF Station:

2.1.1. Parents shall drop and pick up their children **outside the school premises** only at **Gate No. 4**.

2.1.2. Students shall walk from **Gate No. 4** to their respective classrooms in an orderly manner.

2.1.3. Parents are requested to ensure punctuality during drop-off and pick-up times to avoid crowding at the gate area.

2.1.4. The school security staff will assist in ensuring the smooth movement of students during arrival and dispersal times.

2.2. For Parents residing outside the AF Station:

2.2.1. Parents shall drop and pick up their children outside the Air Force Station premises only.

2.2.2. Students shall walk from the Station Gate to their respective classrooms via **Gate No. 6** in an orderly manner.

2.2.3. Parents are requested to ensure punctuality during drop-off and pick-up times to avoid crowding at the gate area.

2.2.4. The school security staff will assist in ensuring the smooth movement of students during arrival and dispersal times.

3. Staff / Visitors Vehicle Parking

3.1. For two wheelers:

3.1.1. No staff or visitor vehicles are permitted within the school compound at any time.

3.1.2. All staff members and visitors shall park their vehicles on the designated peripheral road (**near Gate No. 6**), which lies inside the Air Force Station but outside the school boundary.

3.1.3. Staff are advised to ensure that vehicles are properly parked without obstructing movement or emergency access routes.

3.2. For four wheelers:

3.2.1. No staff or visitor vehicles are permitted within the school compound at any time.

3.2.2. All staff members shall park their vehicles on the designated peripheral road (**near Gate No. 3**), which lies inside the Air Force Station but outside the school boundary.

3.2.3. Staff are advised to ensure that vehicles are properly parked without obstructing movement or emergency access routes.
